

Dear Camper and Family,

We are excited to announce that Camp Concern will be hosting retreat days this July! You will be able to see your friends and counselors and be part of an experience where we pack a week of Camp Concern into a single day for only \$10! While this day will not look exactly like the camp we know and love, it will still be filled with the love and joy of Christ. You will participate in classes, share a meal, and play some games all at the Campsite #2 that we know and love! Feel free to invite a new friend to come enjoy the fun too!

Please know that all campers and staff are expected to abide by the same rules and screenings without exception. We kindly ask for your patience and understanding as this is a different experience for all of us. We will be following the CDC guidelines for summer camps which means at this time the following procedures will be in place. These guidelines are not optional – only come if you are willing to abide by them completely, however, please note that guidelines are subject to change based on current CDC summer camp guidelines at the time of events.

- **Campers are required to complete a health self-screening within 48hrs prior to scheduled event. If unable to pass health screening you will be asked to refrain from attending. If unable to attend due to health reasons, your registration fee will be refunded.**
- **Following CDC camp guidelines, masks are not required during outdoor camp activities regardless of vaccination status. Masks will be required if activities are moved indoors or social distancing cannot be maintained. You are asked to bring a mask with you for this reason. Campers and staff who are considered high-risk are encouraged to still wear a mask and anyone is welcome to wear a mask if they so choose. Please note that these guidelines are subject to change to continue to follow current guidelines.**
- **On site check-in the day of your event will be done from your car. All visitors are asked to stay in your vehicle, where a staff member will complete a health screening and questionnaire. Only the camper is permitted out of the vehicle once screening is completed.**
- **If any illness presents during the day event, emergency contact will be immediately notified and camper will be sent home.**
- **Hand washing and sanitation will be encouraged throughout the day. Supplies and areas for such will be readily available. Extra steps will be taken by staff to encourage social distancing and cleanliness for all campers' safety.**
- **Day activities are planned to be held entirely outdoors, however in the event of poor weather conditions, multiple buildings are available on site to accommodate social distancing.**
- **Pickup will follow drop off routine. All visitors will be asked to remain in their vehicle and child will be brought to you. Please be prompt for pickup times noted below.**
- **Within two weeks following camp, if your camper is diagnosed with COVID-19, you must report this to Camp leadership following reporting practices in accordance with CDC guidelines.**

Please fill out the enclosed registration/medical form and return it as soon as possible. After we receive your registration with your registration fee, we will send out a letter with schedule details and any further information. Additional forms and information are available at CampConcern.org. Feel free to reach out to your director if you have concerns leading up to camp. We are so grateful that we are able to plan these events and have a Camp Concern experience this summer. We have missed you and can't wait to see you soon!

Health Self-Screening

Must be answered by your camper within 48 hours of your scheduled event. Will also be completed at registration with temperature check.

1. In the past 14 days have you or someone you have had direct contact with been exposed to or diagnosed with COVID-19?
2. In the past 14 days have you experienced any new onset of the following symptoms?
 - Fever/chills
 - Cough
 - Shortness of breath/difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
3. In the past 14 days have you or someone you live with returned from travel outside the country?

If answering yes to any question above, we kindly ask you to refrain from attending camp. We understand this will be disappointing, however we all must do our part to keep our camp family safe. Thank you!
